Providing Quality Services

Insurance Services Office (ISO)

Residents of the communities of Miami Township and Miamisburg receive an ISO rating of 3X from the Miami Valley Fire District which helps them receive better rates on their property insurance.

Quality Services Pay off

Residents in communities with desirable **Example** ratings from the Insurance Services Office (ISO)

are usually charged less for their property insurance. ISO ranks Miami Valley Fire District in the top 17% in the US. If this levy is successful, we could

potentially move to the top 5% in the US.



The Cost of Services

Who Votes Residents of Miami Township and City of Miamisburg

Cost to Outfit One Firefighter: \$21,700 Includes \$8,600 in gear from helmets to boots, plus \$13,100 in equipment including Self-Contained Breathing Apparatus.

Cost for One Ambulance: \$382,000

Includes \$287,000 for the vehicle and \$95,000 for equipment and supplies. The average age of the Districts medics are 12 years old.


Cost for One Engine: \$657,000

Includes \$607,000 for the vehicle and \$50,000 for fire hose, radios, and other miscellaneous equipment. The average age of the District's fire engines are 17 years old.

Cost for One Ladder Truck: \$1,500,000

Includes \$1,350,000 for the vehicle and \$150,000 for fire hose, radios, and other specialized equipment.

A Growing Demand for Services



Since 2013 we have seen an over 40% increase for calls for service.

11-Mill Fire & EMS Levy Snapshot

What it Funds

- Personnel to manage increased call volume
- Additional positions to staff all stations
- Necessary replacement of Fire/EMS equipment
- Continuation of current service levels
- Repairs existing facilities
- Station Replacement Projects

The Cost

Revenue

- This Levy is projected to last at least 10-15 years
- Funding from City and Township will no longer be necessary

Easing the Burden for Taxpayers



The Fire District actively seeks non-taxpayer sources of revenue such as:

Grants – We have applied for \$1,545,376 in Grant Funding. We have received \$134,268.

Insurance Billing – In 2021, 10% of the fire department's total revenue came from billing insurance providers for emergency medical transports.

Sold Obsolete Equipment - We have sold \$155,956 worth of Obsolete Equipment.

Cost Cutting Measures to Balance the Budget

Before asking for additional funding, the Fire District has reduced spending. Cuts have included:

- Closed Station 51 in 2019 to minimize overtime and control budget
- Delayed Radio, IT and SCBA equipment replacement
- Positions left open after retirements and resignations
- Limited all non-essential training, building repairs and equipment

The levy will allow us to restore these items and replace equipment on a recommended industry schedule.
