**Call to Order**

### **Chief's Report**

The Insurance Services Office (ISO) report was released, and the District remained at a Class 3, however, gained points and are hoping to move up to Class 2 the next time. The ratings are reviewed every 7 to 10 years.

The District received two donations. Tempur-Pedic donated 20 new mattresses and Lowe's donated several appliances, including a new washer and dryer, dishwasher and refrigerator.

There is an information meeting for the upcoming levy at the Plaza Theatre on Monday, October 24, 2022, at 6:00 p.m.

There are ongoing fleet maintenance issues, and they are looking at new companies, and other options to help with this issue.


### **Trustee Comments**
