Chief Barnett stated that Station 51 will reopen on a 24-hour basis on June 12. Chief Barnett stated that he will provide information on the grant writer contract at the July meeting. Staff is still waiting to hear if the personnel grant has been funded. The Eagle's approached the Chief to see if they could utilize the public safety grant that is offered through their organization. The Chief submitted replacement of the District's floatation devices. The Chief will introduce Ms. Harover, Ms. Phillips and FF/PM Fellers at the July meeting. The Chief explained the soft billing process to the Board. Miami Township and City of Miamisburg residents shouldn't receive a direct bill from the Fire District.
