RESOLUTION NO. 2023-19

A RESOLUTION TO AUTHORIZE THE FIRE CHIEF TO ENTER INTO AN AGREEMENT WITH ESO FOR FIRE AND EMS RECORD MANAGEMENT SYSTEM PURPOSES.

- WHEREAS, the City of Miamisburg, Ohio and Miami Township, Montgomery County, Ohio created the Miami Valley Fire District (the "District") consistent with Ohio Revised Code Section 505.371 via Joint Resolution, City Resolution No. 2786 and Township Resolution No. 121-2011; and
- WHEREAS, the Miami Valley Fire District recognizes the need for a comprehensive and efficient fire and EMS record management system to enhance operational effectiveness and improve data accuracy; and
- WHEREAS, ESO has been identified as a reputable and experienced provider of fire and EMS record management solutions, with a track record of successful implementations in similar organizations; and
- WHEREAS, ESO has proposed an agreement for the provision of fire and EMS record management services to the Miami Valley Fire District, which includes an initial cost and subsequent payments for the duration of the agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE MIAMI VALLEY FIRE DISTRICT BOARD OF TRUSTEES THAT:

Section 1.

The Fire Chief is authorized and directed to enter into an agreement with ESO, attached as "Exhibit A", for the provision of fire and EMS record management services, in accordance with the terms and conditions outlined in the agreement.

Section 2.

The Fire Chief is authorized to make payments according to the payment schedule attached as "Exhibit B".

Section 3.

The Fire Chief is further authorized to take all necessary actions, including negotiations and contract execution, to finalize the agreement with ESO.

Section 4.

It is hereby found and determined that all formal actions of the Board concerning and relating to, adoption of this Resolution were adopted in an open meeting of the Board, and that any and all deliberations of the Board and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including, but not limited to Section 121.22 of the Ohio Revised Code.

Section 5.

This resolution shall be in full force and effect August 10, 2023 and shall supersede any prior resolution or act of this Board, which may be inconsistent or duplicative with the provisions of this resolution.

Hi Chief Barnett,

This email is intended to walk through the Emergency Reporting to ESO upgrade process and associated costs.

Bullet Point Steps in Order to get started with on ESO Software:

- 1. Quote needs to be signed and returned to ESO.
- 2. Once that is signed, Miami Valley Fire District will go into the queue for implementation and ESO training.
- 3. A member of our implementation team typically reaches out within 48 hours to kick off project and discuss project timeline and order of importance with you.
- 4. Project kick-off happens and data migrations commence.
- 5. Project team will work with you until fully live on all products in scope and data migrations complete.

The ESO contract cost is broken down over three years and will be listed in detail later. While the department is going through implementation for ESO, the Emergency Reporting contract will remain active and will renew on the first of the year as it has in the past. This means you will have two active contracts with ESO, one for ESO software and the second being for Emergency Reporting. The reason being is so we can ensure a smooth transition and data migration process. You are able to cancel the Emergency Reporting contract at any time but is not recommended until the ESO renewal in year two. Once the Emergency Reporting contract is canceled, you will receive a credit applied to your ESO invoice for the remaining months within that contract period. Below, I'll list the cost breakdown assuming the department signs with ESO on 8/1/2023 and will cancel the Emergency Reporting contract on 8/1/2024.

Year 1 (2023): ESO cost due in August will be \$1,375.00 (One-time fees) Emergency Reporting renewal cost due in December \$20,261.20

Total: \$21,636.20

Year 2 (2024): ESO cost due in August 2024 will be \$20,261.20

Emergency Reporting contract will be canceled, and an estimated credit of \$8,442.16 will be applied for the remaining five months of the contract.

Estimated Total to be paid after credit: 11,839.04

Year 3 (2025): ESO cost of \$35,411.70
