MIAMI VALLEY FIRE DISTRICT BOARD OF TRUSTEES MEETING MINUTES April 11, 2024

Call to Order

President Stalder called the Miami Valley Fire District meeting to order at 8:00 a.m. and led the Pledge of Allegiance.

Roll Call

The following Trustees were present: John Stalder, Ann-Lisa Allen, Greg Bell, Frank Fritsch and Terry Posey. The following staff members were present: Chris Snyder, Emily Christian, Brandon Barnett, Steve Johnson, Jennie Harover, Elyse Martin and Amy Phillips.

Meeting Minutes

A motion was made by Ms. Allen, seconded by Mr. Fritsch to approve the Regular Meeting minutes of March 14, 2024. Motion carried.

Public Comment

Bob Spirk, President of Local 1832, acknowledged retired Miami Township Administrator, Ron Hess and thanked him for attending today's meeting. He commented that the agenda items for today's meeting will be good for the entire district. He wishes the best of luck to both Chief Barnett as well as BC Johnson on their future positions with the District.

The Board recessed into a public study session at 8:03 am to discuss:

The Board recessed out of public study session at 8:22 a.m.

Elyse Martin presented a request to approve the District Finance Manager to move \$3,030.18 in outstanding checks to the unclaimed money fund. This request will allow outstanding checks to be placed in the Unclaimed Money Fund for a period of 5 years. If at any time the rightful owner of these funds requests payment, the money will be moved back to the General Fund to be

expensed. Once the five years have passed without being claimed, the money will be moved back to the General Fund.

A motion was made by Ms. Allen, seconded by Mr. Fritsch, to approve District Finance Manager to move \$3,030.18 in outstanding checks to the unclaimed money fund. Mr. Stalder aye, Ms. Allen aye, Mr. Bell aye, Mr. Fritsch aye and Mr. Posey. Motion carried.

Chief Barnett presented **Resolution No. 2024-08**. The resolution will approve the renewal of the District's agreement for medical insurance with Medical Mutual of Ohio at a rate increase of 5%. District employees will pay 20% for their medical coverage premium, choosing between a High Deductible Health Plan and a PPO Plan, with the District funding the remaining 80% of premiums. The District will also provide an HSA employer contribution of \$1,000 for eligible employees that select a High Deductible Health Plan. Dental (Superior Dental Care) and Vision (VSP) coverage premiums are 100% employee responsibility. A motion was made by Mr. Fritsch, seconded by Ms. Allen, to read Resolution No. 2024-08 by title only. Mr. Stalder aye, Ms. Allen aye, Mr. Bell aye, Mr. Fritsch aye and Mr. Posey aye. Motion carried. **A RESOLUTION TO PROVIDE FOR THE PAYMENT OF GROUP HEALTH INSURANCE, DENTAL AND VISION BENEFITS AND TO ESTABLISH A HEALTH INSURANCE WAIVER PROGRAM FOR ELIGIBLE MIAMI VALLEY FIRE DISTRICT EMPLOYEES EFFECTIVE JUNE 1, 2024.** A motion was made by Ms. Allen, seconded by Mr. Fritsch, to adopt Resolution No. 2024-08. Mr. Stalder aye, Ms. Allen aye, Mr. Bell aye, Mr. Fritsch aye and Mr. Posey aye. Motion carried.

Chief Barnett presented **Resolution No. 2024-09**. The resolution will authorize the Board of Trustees to reclassify Fire Chief Thomas B. Barnett. A motion was made by Mr. Fritsch, seconded by Ms. Allen, to read Resolution No. 2024-09 by title only. Mr. Stalder aye, Ms. Allen aye, Mr. Bell aye, Mr. Fritsch aye, and Mr. Posey aye. Motion carried. **A RESOLUTION TO AUTHORIZE THE RECLASSIFICATION OF FIRE CHIEF, THOMAS B. BARNETT TO ASSISTANT CHIEF.** A motion was made by Mr. Fritsch, seconded by Ms. Allen, to adopt Resolution No. 2024-09. Mr. Stalder aye, Ms. Allen aye, Mr. Bell aye, Mr. Fritsch aye and Mr. Posey aye. Motion carried.

Chief Barnett presented **Resolution No. 2024-10**. The resolution will appoint Steven Herschel Johnson as Fire Chief of Miami Valley Fire District following the reclassification of Thomas B. Barnett to Assistant Chief. The resolution was read in its entirety. A motion was made by Mr. Bell, seconded by Mr. Fritsch, to adopt Resolution 2024-10. Mr. Stalder aye, Ms. Allen aye, Mr. Bell aye, Mr. Fritsch aye and Mr. Posey aye. Motion carried.

Chief's Report

Chief Johnson thanked the Board for his appointment to Chief. He explained that the District previously executed agreements for two new fire engines. The agreement with Sutphin signed in 2021 had a delivery date of 2024 which has now been pushed back to March of 2025. The more recent agreement with Spartan has a 240-day delivery expectation and should arrive in early December. A new medic should be arriving mid-summer and the District has received pictures of it going through the building phase. An "experienced" engine has been received from the City of Vandalia. It has gone through some mechanical adjustments as well as District labeling and has been placed in service. This has been a good purchase for the District and will be easy to identify as it is seen within the community. As an employment requirement, all firefighters

must obtain their inspector certification. Eleven members of the District will begin an 800-hour class to receive inspector status. This class will be done in-house at Station 54 by instructors from Warren County Career Center. Members can attend this class while on duty allowing the District to save on coverage of job duties. Class will begin next week and finish up by the end of June. Jerrod Widener has submitted his resignation and will be moving to Butler Township. While this is a great opportunity for Jerrod, he will be greatly missed at the District. His last day of service will be April 24th. District policies are being reviewed and revised through Lexipol. Administration staff is meeting with Lexipol once a week as policies are rewritten, focusing on 3-5 policies each week, and will most likely continue through the end of the year. An RFP for EMS billing services is almost completed. It will be reviewed by our legal team before being publicized in the next week. This process will take approximately 90 days and will then be brought before the Board for approval. Change Healthcare has given us notice of termination at the end of December and this RFP should allow us to be ahead of that deadline. The District had no issues with recent storms nor with the eclipse. All new employees have been cleared of their "greenbook" training assignments and have been released to their respective stations. There will be a retirement celebration for Elizabeth Zink held at Station 52 on April 18th from 2:00-4:00 p.m.

OCC Report

Chris Snyder thanked Brandon Barnett for his service to the District as Chief for the past two years and he looks forward to his future commitments with the District. He also congratulated Steve Johnson on his acceptance of Fire Chief. He wishes him the best and looks forward to working with him in this new role.

Trustee Report

Trustees thanked Brandon Barnett for his service as well as his continued support with the District. They congratulated Steve Johnson on his new role as Fire Chief.

Adjournment

A motion was made by Ms. Allen, seconded by Mr. Fritsch, to adjourn the meeting at 8:36 am. Motion carried.
